## **Financial Report and Financial Projection** (David K.)

- Prepaid pledges are held in reserve for next year
- David is projecting that we will be \$15,000 in the negative by the end of the church year, even though we were up 100,000 through March. This is a very conservative projection.
- Assuming a loss of rentals and Mariposa payments
- Plate and pledges have not dropped
- We put in for a small business loan, were excepted, but the funds ran out. Possible with the new relief package

# (Vote 1). Consent agenda: Minutes, Minister's Report, DRE report, Financial Report

- The previous minutes were amended to include Maggie Carey as attending by the clerk.
- Vote made by Steve, seconded by Maggie. Vote passed unanimously.

#### **Policy of the Month** (Marie and Sara)

**Bylaws**. Read:

• ARTICLE VI—Congregational Meetings and Voting,

**Proposed Plan for Annual Meeting (from Exec):** Because of the Coronavirus pandemic, and using both state and UUA guidelines, the 2020 Annual meeting will be held as a Zoom meeting, since we have had such success with Zoom Sunday services.

- Push it out to May 31 to give us more time to plan
- Push the budget meeting to May 5 so stewardship has some time for their "cleanup"
- Conduct the meeting over zoom (redefining "in person" in times of pandemic).
  - See UUA links below
- Only vote on the budget, not on new committee members
  - Need to get agreement from the committee members who are scheduled to go off to keep their positions until, say Fall of 2020
- Come up with a simpler form for committee annual reports so we can close out this year.

- Maybe just collect answers to a couple questions from each committee chair. Sara is working on this.
- Use the meeting to get input from the congregation on "how we go back", with targeted questions and comments solicited in advance.

# **Discussion on Annual Meeting Plan:**

- LDC needs to be notified that the current officers and committee members will carry over until the Fall. LDC should reach out to make sure people want to continue until then.
- Sara presented a simplified report form for all committees, to be filled out and used for the Annual Report and meeting. To include committee name, purpose/mission, chair, committee members (terms and dates), major activities through Feb. 2020, 20/21 priorities/challenges/improvements/opportunities
- Vote #2: To extend all officers, chairs, and committee members until Fall of 2020 when
  a second congregational meeting will be held for elections. Motioned made by Maggie,
  seconded by Celia. Motioned pass unanimously.
- Sara will reach out to Joan and get the form to all committee chairs.

# **Trustees Presentation by Jeff Keffer:**

- Jeff gave a history of how the endowment funds had been spent historically, and the many year effort to stop depending on the endowment to balance the operating budget.
- UUA supports that endowments are to be used for capital and long-term strategic needs
- When the by-laws were updated, it was clarified that the Trustees report to the congregation (not Parcom) and their role is to protect the long-term existence of the church
- The base amount of the general fund was set in 2007at \$1,270,000. It has never been adjusted for inflation, and the base fund needs to be maintained. If it was adjusted for inflation, the base amount would be closer to \$1,782,000. Today (after the market decline), we are about \$200,000 under that adjusted base amount.
- The use of these funds in "an emergency" or for the long-term welfare of the church are not defined.
- Jeff suggested one option that has been used before is Parcom requesting a loan that would be repaid over time
- Any major use of the funds might need to be voted on by the congregation
- Parcom asked if the Trustees would be able to be a backstop if we run into difficulties because to the pandemic (such as the loss of rental income, etc.). Jeff said the Trustees would work with Parcom if that happens. He suggested we set as money in the budget for pandemic costs.

#### Final Annual meeting plan (Vote #3):

- 1) Parcom will call a Zoom annual meeting for May 31.
- 2) The final Parcom budget meeting will be held May 6.

- 3) To best meet the "in person" annual meeting goal, all members will be required to register prior to the meeting, membership checked, and be given an access code. Where two people in one household are attending, arrangements will be made for the second vote.
- 4) The main part of the agenda will be the budget, and the putting off elections until the Fall.
- 5) Committee reports will be simplified with a standard form
- 6) Some discussion will be held about how we "go back" to being a congregation once the state and town have lifted restrictions on meetings.
- 7) **Vote #3**: Motioned made by Tom Estabrook, seconded by Steve to adopt the Annual meeting plan. Motion passed unanimously.

Ministers Report March

March 19 - April 19, 2020

The First Month of the Corona Virus Pandemic

Rev. Marta Morris Flanagan

On March 16 the Governor closed all schools in the Commonwealth. On March 23 he issued a stay at home advisory. This report essentially covers the first month of ministry during this pandemic.

Our first death to Covid-19 occurred on April 14. Janelle Slobodkin, 77, was a longtime member of First Parish and served as Chari of the Parish Committee some thirty years ago. Her husband, Sid Slobodkin, is a member and regularly attends our men's group. Our thoughts and prayers are with Sid.

I am aware of several parishioners who have symptoms and are confined to home. I am also aware of several parishioners who have already lost parents to Covid-19. We are a religious community living through and responding to a crisis.

Doing that well involves enormous change. The staff have been learning new technology and working to create alternative ways of supporting and being in community.

Recreating the wheel of how we do things in innumerable areas, managing the inevitable conflicts as we do so, and working with people's stress and anxiety is an enormous endeavor. I am enormously grateful to the staff and lay leaders who are stepping up and making our ongoing ministry possible.

DRE Report to Parish Committee April 10, 2020

Hello Friends,

What a month it's been! Thank you for all your support as we transition from our former job descriptions to whatever is now required of us to sustain and build our spiritual community together.

#### Here is what I have been working on:

Organized a **survey** for parents to learn what kind of help they and their children might need from First Parish. Of the 140 families who were sent the survey 30 families responded.

## Because of those results I have set up:

Zoom Parent Get Togethers 3 x per week at varying times to try to meet parent availability Zoom Toddler Sing a long with Diane Taraz

Zoom Sunday group gatherings by grade for our children. First classes (for the younger children) begin this Sunday (Easter). I have recruited teachers the children know and have prepared age appropriate activities for all. Older kids will begin on April 19 and the focus will be Earth Day.

OWL, COA and Youth Group are meeting regularly on Sunday evenings

I am extremely grateful for the time and energy Rose put into establishing methods of connecting with our youth group! From the first week she set up all group meetings, smaller peer counseling sessions, fun get-togethers like yoga, cooking and music. During youth group at least 30 youth are participating. They share joys and concerns and play games together.

I am collaborating with my DRE colleagues to pool our resources to offer a more substantial weekly news letter with suggestions for at-home religious conversations/rituals/learning.

The RE Committee has met. Together we are sending cards to all the children in our program.

I am gathering a team of people to work on all congregation fun activities like virtual art show, Earth Day celebrations and recipe sharing. Dealing with the tools and techiques to gather materials is taking time, but I am hopeful that these projects can be launched soon.

**Worship:** I have collaborated with Marta, Chloe, Jonathan and the worship associates for Sunday morning worship and have led the Time for All Ages twice. I recruited Jen Davis Kay on the Sunday when I was not available to lead. I plan to continue leading them over the next month.

**Meetings:** I meet regularly with Marta, Rose, Chloe and the staff. I check in weekly with all members of the RE Committee, OWL teachers and COA mentors.

I attend monthly youth group YAC meetings and weekly youth group gatherings.

I participated in the New UU Class last Saturday.

#### Pastoral:

I have reached out to those adults and children who are struggling with our new normal.

# **Special Thanks and Appreciation:**

Goes to our amazing office staff - Joan and Sara - who are doing a fantastic job of keeping the community connected through our various tools. Joan especially has been a huge help for me as I'm trying to learn the new methods of connecting.

And to Marta who is running as fast as she can to maintain a high level of worship, ensure our congregation has ways to support one another, secure a fantastic candidate for second minister, and do the business of the church.

And thank you all for continuing to lead us as we figure out what's next.

# First Parish Unitarian Universalist of Arlington M Budget vs. Actuals: Monthly - P&L Budget FY 2020 - FY20 P&L

July 2019 - March 2020

March FY20 YTD results continue strong, \$103k net income for 9 months. Pledges (acct 4110) are continuing ahead of budget due to numerous pledges being paid early, consistent with experience in previous years. Net result for March alone, virtually break even (\$381 loss). \$58k pledges received March. Little effect so far overall of crisis.

\$32,200 of FY21 pledges received, moved to "pledges for future year" on balance sheet

Salaries and other personnel expenses are under budget due to lower than expected hours and expense relating to communications associate, youth coordinator, sexton, ministerial intern, others. FICA appears not fully budgeted on all salary budget hours, leading to low FICA budget variance.

\$3,800 paid for new kitchen fan (acct 5530), also \$4,050 paid for annual elevator inspection (acct 5521).

Parcomm expenses (acct 5810) - \$32 for baking, \$500 for holiday gifts

#### Balance sheet:

Second minister fund pledges received are up to \$189,200 out of a goal of \$216,000.

Spending from the second minister reserve fund totals \$4,094, for Beyond Categorical Thinking, child care, survey expenses. Also candidate hosting & travel (\$3,194).

Final Hallee family gift (\$10,000) has been received, added to trust funds. \$10k Housing contr. rec'd from trustees.

Trust funds for March (\$2.4 million) **below** June 2019 levels (\$2.7 million) due to downturn. Alliance fund \$407k, was \$431k as of June 2019.
