- Net income down slightly
- Salaries are under
- Projects slight surplus for this year; \$10-25,000 surplus possible
- Market back up in April; Trust funds grew back about \$200,000
- This does not count the PPE we will receive.

## Summer Building use:

- Left over search committee costs can be used for office set-up and moving costs for the 2<sup>nd</sup> minister.
- UUA recommends only using 40% of capacity (looking for occupancy #s)
- Before use, cleaning required
- Awaiting COVID-19 task force recommendations
- Marta recommends not using all summer
  - Need spacing signage
  - Possible exception for funerals
  - No food prep, or bathroom usage
  - Mariposa rules, drop-off, elevator usage, vestibule area
  - Use by NAAA, AA, funerals-stress equity and very limited use
  - o Question of the use of the courtyard for meetings

#### **Ministers Report March April 20-May 16, 2020 The Second Month of the Corona Virus Pandemic** Rev. Marta Morris Flanagan

This was the month the congregation virtually met Rev. Erica Richmond, who will start as our new Parish Minister in August. Erica offered the homily during zoom worship on May 3 and she met with those who are and who have served on the Parish Committee over the last five years. Over the next month she will hold two other small gatherings online to meet leaders as well as meet with individual staff members.

We are off to a good start! The Second Minister Search Committee has received only positive feedback about Erica, including 17 emails from parishioners. I note how wonderful it is to witness her interactions with leaders and listen afresh to you tell the stories of your commitment to First Parish.

This month we continued to adjust to life in the midst of the corona virus. Governor Baker issues a stay at home advisory on March 23. This is the second month of being a religious community in a pandemic. The meetinghouse is closed; worship and all meetings and programs are online – including the choir, the Youth Group, Coming of Age programs, some religious education classes, covenant groups, three Lectio Divina sessions each week, four Spirit Talk sessions, and more. Through the FP Connection board numerous discussion groups and even concerts are offered. With the coordination of Lori Kenshaft a phone buddy system is connecting approximately 30 pairs of people. Sunday morning worship includes breakout groups, a virtual social time, and sharing on the chat. Attendance at worship remains slightly higher than average Sunday worship in the sanctuary. None of this would be possible without the tech team and many individuals behind the scenes

Thankfully during this month we have had no deaths due to COVID 19 in the First Parish community– though there are individuals who have been symptomatic at home. And several members are grieving family members who have died of the virus and are worried about others who are ill.

Much of the talk at staff and committee meetings is about mastering how to do things well on new virtual terms. There is also much discussion about what eventual phasing back will look like. There are numerous unknowns including timing, best health practices, and costs. As I told staff last week I have not felt this green or inexperienced in the work of ministry since I started at the first church I served 33 years ago. It is exciting and unnerving!

Last week the UUA issued an advisory to congregations encouraging planning for online worship through May 2021. Governor Baker is expected to announce details about any reopening plans tomorrow. For now we will remain a religious community online through Labor Day. Beyond that is still to be determined. For now we look toward the annual meeting, May 31. I am pleased with the budget the Parish Committee adopted. It is the first budget in more than twelve years in which we have had to cut committee budgets and not give staff COLA increases. But under the extreme financial circumstances the world is under, I am impressed and grateful for our wellbeing as a religious community.
