Call to Order

Reading and Chalice Lighting. (Maggie) – Amanda Gorman poem Two minutes of silence

Financial Report & dashboard (David)

- Pledges returned to their expected level in March.
- We will likely have a surplus at the end of June because of higher pledges, plate, flood insurance, and lower than anticipated salary costs resulting from Parcom's conscious decision to keep some personnel costs in the budget because of uncertainty about the pandemic.
- Property expenses reflect two flood events and related repairs to the annex and music room. Insurance reimbursement will offset costs.
- Need future discussion of what to do with any net income at a future Parcom meeting.

Vote 1, Discussion. Consent agenda: Minutes, Financials, lead Minister's Report, Parish minister's report. Motion made by Paul, seconded by Maggie. Motioned passed unanimously.

Updates and Votes

- Annual Meeting Update (Anne & Celia)
 - Preparations are in good shape. Registration set up, notice in ebulletin, warrant to be voted on tonight.
 - Sara G is working on a retrospective slide show for the meeting.
- Vote 2 on warrant- Motion made by Steve, seconded by Anne. Motion passed unanimously.
- Stewardship Update (Rev. Erica)
 - Pledges to date total \$722,000 which is \$17,000 over the goal.
 - This total includes 12 new pledging units. 60 pledging units account for 50% of the total pledges, which reflects a healthy community. Pledges went up an average of \$200.
 - Stewards report that members appreciate the Parish Committee's fiscal responsibility.
- Budget update (Marie)
 - o The Parish Committee will vote on the budget April 27th.
 - The successful stewardship drive means that most of the priorities identified in earlier discussion can be funded.

- Suggestions for the additional funds: funding Action Sunday, audit, HVAC, painting sanctuary, etc.
- "Outside" property (Marie)
 - Proposal to set up a temporary garden committee, as the people who have traditionally maintained the gardens are looking to step down, and to provide \$300 for gardening supplies.
 - Vote 3 To set up a gardening committee for two years funded with \$300.
 Motion by Steve, second by Anne. Motion passed unanimously.
- Policy of the month: Capital Infrastructure Funds Please Review
- Vote 4: Approve Annex HVAC repairs using Capital Infrastructure Funds
 - The cost of repairing upgrading the HVAC system in the annex will require about \$22,000 from the capital infrastructure fund. The Trustees have noted this is an appropriate withdrawal.
 - Motion made by Celia, seconded by Maggie. Motion passed unanimously.

State of the church (Marta)

- Stewardship results and the recently completed review of the ministers and ministries reflect positive feelings among the congregation.
- COVID-19 and the Derek Chauvin conviction have been dominating themes.
- We are at a threshold moment:
 - Christian congregations are on a decline.
 - o In five months we will be back in the building
 - In 30 years the US will be a majority minority country
- How will FP thrive in such an environment?
 - Need to adapt to a post-Covid environment.
 - Need to serve a greater diversity and interest in spirituality.
 - Focus on community.
 - Celebrate the changing demographics of our country and create a culture of flexibility.
 - Create a stability and rituals for people to hold on to
 - o Might need to partner with other organizations to increase our diversity.
 - Spirituality and social justice are still the main interests in our membership.

Returning to worship: (Marie) (10 mins)

 Results from the Question Formulation Workshop – wide range of issues, concern about health & safety. This will be boiled down and there will be 2 after church focus groups. In addition, we anticipate another congregational survey about returning to inperson worship.

RE Update- Ellen Robie

- Tina gave thanks to Ellen's terrific role leading RE during the pandemic.
- This spring the RE program is targeting 4–7-year-olds for programing, COA and youth group.

- Phase 2 will be for grade levels up to Youth Group There are many open questions to address, including vaccination requirements for teachers and vaccination guidelines for children.
- Plan is for OWL to be in person in the building by Sept.
- · Youth Group is still talking about their fall.
- Suggestion of a tent in the courtyard for meetings outdoors

Letters of Agreement (LOAs) for Marta & Rev. Erica (Sara)- Executive session
The major changes were to fix typos, clarify that Marta is the "Lead Minister" and to
extend the self-funded short-term disability benefit to both ministers. A copy of the
LOAs will be kept in the office for the record. Vote 5: Motion to approve the revised
LOAs made by Steve, seconded by Celia. Motion passed unanimously.

Committee on Ministry- Marie

 There are two vacancies for next year because Alan Schweitzer's and John Anderson's terms have expired. Marta explained the process for recruiting new members and sought Parish Committee input.

What a month it has been. The world continues to be a place of heartache and violence, especially racialized violence and harassment. I am grateful to RJCC providing a timely debrief the recent events and to our emergent issues task force for quickly getting a banner up about standing against Asian hate.

In good news, we have exceeded our Stewardship goal! Now we are wrapping up thank you notes and the like. A huge shout out to the Stewardship Committee and Marie for their work. I appreciate the re-opening conversations we all continue to have. Beyond the airflow and tech logistics, Marie's workshop raised for me the reality that all of us will have to model what it means to be non-anxious in the face of anxiety provoking realities.

And, a thank you to each of you for engaging in the ministerial evaluations. It is an honor to serve this congregation.

Worship:

I preached on March 21 about the one-year COVID lockdown- this included themes of Passover and the Jewish tradition of ritual immersion.

I provided the prayer and Stewardship ask on March 28th.

I preached on Easter Sunday, April 4th. I was joined by guest musician Matt Meyer. I was off Alliance Sunday, April, 11th.

I am providing the prayer and Stewardship celebration on April 18th.

I continue to lead Wednesday evening chapel, this has been an ongoing experiment since January. I am planning on continuing it until at least the end of April and might pause it at that point until the Fall.

Pastoral Care Provided by Minister

I continue to provide spiritual care to individuals and families. Themes include anticipatory grief and family support.

Individual pastoral care sessions: 6, in addition Marta and I had 9 1:1 pastoral appointments with folks who just did new UU 1:1 Committee leadership support: 6

Not for a FP member, but just of note, I did a graveside burial service for a local family through the DeVito Funeral home. They had reached out to us looking for a Unitarian minister per the deceased's wishes and I was able to do that on 3/25.

Lay Ministry:

Monthly meeting on April 7th. This group of people continues to do amazing work. I am so glad that the retirement transitions peer group went so well- they are offering a second session in April! And the grief group also continues to meet monthly and that

is also facilitated by two lay ministers. The work of this committee continues to be deepen and is doing a great service to our congregation.

April 4: Spring Interactive Story, "How March Got An Extra Day" (an Italian folktale). Offered by Wendy Fields and me with musical guest Anne Goodwin and actors Zibbi Kloss (grade 3) and Nola Bright (grade 2)

April 11: Family Hike at Habitat Wildlife Sanctuary, led by Luchy Roa and Tim Keefe

April 18: Earth Day and Gnome Yoga, led by Peggy Gardiner and me

Fun Connections:

We offered an on-line Easter Egg Hunt, along with many other UU Congregations Pinwheels of Hope were gathered and displayed on the FP lawn

A Gnome Hunt has been set up arou nd the FP campus during school vacation week (fyi: my colleagues like this idea so much that two others are borrowing the gnomes and format for their congregations, too.)

Coming of Age Group:

Reverend Erica joined with a meet and greet session, and talked about spirit homes.

Seth Botos, Youth Group Advisor, met with the class to discuss our Youth Group and to have a musical evening of group percussion.

A Labyrinth Walk and Meditation at Bethany House of Prayer took place last weekend. Credo writing will begin in earnest following school break.

Youth Group:

Rose offered an outdoor hike, as well as evening programming. We were pleased that six youth who dislike Zoom were present along with eight other teens.

Weekly meetings include topics about race, expression of feelings through art, and ways to support others during COVID.

Youth will be holding a drive to support Rosie's Place during school break. Supplies for health and safety will be gathered in the FP parking lot.

Worship Services:

I organized Time for All Ages on the themes of listening with love as we reconnect, racial justice and recognizing we make mistakes, names for God, and hope.

RE Committee:

I meet weekly with Ellen Robie to review morning and evening programs. The Committee provided input for the program and my evaluation (which will happen later this month).

Ellen has completed her annual report.

We have begun teacher recruiting! As of this writing we have 13 volunteers willing to help with either Phase 1 (most probably outside) and Phase 2 (more probably indoors later in the fall)

Pastoral Outreach:

Reverend Erica and I will lead a Parenting Support Group for those with children of chronic illness or mental challenges on April 26.

I have had zoom meetings and phone conversations with six parents this month on the subjects of anxiety, stress, adjusting back to school, and summer camps for children of color.

Meetings:

I meet weekly with Marta, Rev. Erica, Rose and Ellen Robie, as well as our regular staff meetings.

I am the Zoom host for our Sunday morning programs, as well as the Coming of Age group.

I meet weekly with local DRE colleagues to share information and to learn what other congregations are doing.

I attended the Returning to Worship workshop led by Marie, the Planning for HMF/Yard Sale, Art Show, and Garden/Outdoor Spaces Meetings.

Upcoming Events:

Morning Programming topics will include: Family Worship with Reverend Erica (UU Heritage), Family Walk at Mt Auburn Cemetery, Planting A Rainbow/Earth Worms, Celebrations of Family, and guest story teller Elisa Perman (Parent's Day).

I have organized the Time for All Ages for the next month.

I will collaborate with Reverend Erica, Ellen Robie and Sara Hidalgo, as we begin to strategize reclaiming the RE wing following a year of Mariposa usage.

"Outdoor Property" A committee to manage the grounds

Our gardens have been managed by dedicated individuals, however that work is not "institutionalized", in that there is no formal committee with succession planning or chain of responsibility or way of funding the necessary items like plants and mulch. Specific individuals have taken on specific areas, such as the Pleasant Street garden and the Memorial Garden, but there is no formal communication between these groups. The property committee, which handles the building and has done the lawn mowing, cannot take on managing the gardens, including watering and planting, much less the larger planning, such as replacing the Mass Ave trees.

We are proposing a new committee, the "Outdoor Property Committee" to work alongside the existing property committee to:

- Develop policies for the grounds are in line with our UU values, for example in the choice of plants to facilitate pollination.
- Facilitate communication among those focussed on specific areas
- Continue the close connection between the Religious Education program and those managing the gardens to continue to involve our children and families in tending our little "First Parish earth"
- Provide for succession planning so new people are brought in to keep the committee live and not burn out the current contributors
- Come up with alternative means of funding that involve the community, such as families contributing "memorial trees" or connect with the town tree planning programs.

We propose a committee reporting to ParCom for 3 years with a small core set of members and a set of "mentors" who have been tending the gardens, and provide a budget of \$300 for mulch, plants and other necessities. It should be appreciated that previously these funds were paid by individuals and the RE budget has contributed significantly as well.
